

## Appendix N – Required Number of Parking and Loading Spaces

### Minimum Parking Requirements by Use

Use of Property	Number of Parking Spaces Required
Assembly	1 per 300 gross square feet
Automotive, Boat, Motorcycle, RV and Equipment Sales	5 per 1,000 gross square feet; and 4 spaces per work bay
Automotive Fueling Center	1 stacking space per fueling station; and 5 per 1,000 gross square feet of convenience store
Barber/Beauty Shop	3 per chair or station
Bowling Alley	4 per lane; and Parking required for accessory or affiliated uses such as restaurant, bar, etc.
Church or Place of Worship	1 per 300 gross square feet
Club or Private (Non-Profit)	1 per 3 seats
Daycare Facility	1 per 6 children based on license or permit (pick-up/drop-off may be included); and 1 space per staff person
Dwelling Unit	2 per dwelling unit
Educational Facility: Public or Private	1 per 3.5 seats in assembly rooms; and 1 per faculty member
Financial Institution	5 per 1,000 gross square feet; and 5 stacking spaces per drive thru lane
Funeral Home	1 per 100 gross square feet of chapel area; 1 per funeral vehicle maintained on premises; and 2 per family residing on premises
Group Dwelling	1 per 3 beds; and 1 per staff or visiting doctor
Health & Fitness Center	10 per 1,000 gross square feet
Hospital	1 per 2 hospital beds; 1 per 1,500 gross square feet in residents' quarters; and 1 per each staff or visiting doctor
Hotel	1 per sleeping unit; and 1 per 500 square feet of common area
Industry	1 per 500 gross square feet
Library	1 per 800 gross square feet
Kennel	1 per 500 gross square feet

Restaurant	10 per 1,000 gross square feet
Retail	5 per 1,000 gross square feet
Self Storage	3 per site; and 1 per 50 storage units
Theater	1 per 3 seats
Warehouse	1 per 500 gross square feet
