All permanent sign applications will be reviewed by the Architectural Review Commission (ARC) Chairperson and the Building and Zoning Officer for consideration of approval. If the sign complies with the requirements of the Sign Control Ordinance, then a permit will be issued. If it does not comply with the requirements of the Ordinance or the plans show variances or departures from the requirements of the Ordinance, then the applicant must appear before the full Commission. ARC shall then review the application and recommend approval or denial to the Village Board. Thereafter, the Village Board shall consider the decision of ARC and either approve or deny the application in its sole discretion. The determination of the Village Board shall be final.

If an applicant is required to appear before ARC and the Village Board they shall provide seventeen packets containing the information required by this Section to the Building Inspector or designee two weeks prior to the ARC meeting date. Applicants must submit a \$200.00 non-refundable application fee with their application. If an applicant is denied, does not attend the scheduled meeting, or cancels the meeting within 48 hours of the meeting date, the applicant will be required to submit another \$200.00 non-refundable application fee with any subsequent application or before another ARC meeting is scheduled to review the application.

Conditions of Approval: This permit is issued pursuant to the following conditions. Failure to comply may result in suspension or revocation of this permit or other penalty. _____

The following must also be submitted. If an applicant will be appearing before the Architectural Review Commission, 17 copies of the application and the following information must be submitted two weeks before the scheduled meeting date, along with a non-refundable fee of \$200. If an applicant is denied, or cancels the meeting within 48 hours of the meeting date, the applicant will be required to submit another \$200.00 non-refundable application fee with any subsequent application or rescheduling of meeting.

- A photograph or diagram of the plans and specifications showing the method of construction and the types of materials to be used as well as the method of illumination and support along with this additional information:

For a wall sign: the information on the front of the application and an exact representation of the sign on the face of the building where it is to be attached.

For a ground sign: the location of the sign on the property, including front and side yard setbacks and the distance from the sign to the building; the height of the sign; the property frontage; the distance from the sign to adjacent ground signs and a colored landscape plan. Material sample for any stone, brick or other material to be used.

For a projecting sign: the proposed location of the sign on the building, including the distance that the sign is pinned away from the building, the distance from the face of the building wall to the outer-most point on the sign and the distance between sidewalk grade and the top and bottom of the sign, and an exact representation of the face of the building to which the sign is to be attached.

For a canopy, awning or marquee sign: the complete dimensions of the canopy, awning or marquee to which the sign is to be attached; the location and outer dimensions of the design or lettering; and the distance from sidewalk grade to the top and bottom of the sign.

For a window sign: the dimensions of the window or other glass surface on which the sign is to be applied; the location and outer dimensions of the sign; and the location of any other window signs on the face of the building on which the sign is to be attached.

Each day that a violation is permitted to exist shall constitute a separate offense.
